# INTRODUCTION

# **PROJECT OVERVIEW**

This Community Health Needs Assessment, a follow-up to a similar study conducted in 2019, is a systematic, data-driven approach to determining the health status, behaviors, and needs of residents in the service area of Hackensack Meridian JFK Johnson Rehabilitation Institute. Subsequently, this information may be used to inform decisions and guide efforts to improve community health and wellness.

A Community Health Needs Assessment provides information so that communities may identify issues of greatest concern and decide to commit resources to those areas, thereby making the greatest possible impact on community health status.

This assessment for Hackensack Meridian JFK Johnson Rehabilitation Institute is part of a regional project conducted by Professional Research Consultants, Inc. (PRC) for Hackensack Meridian *Health* on behalf of its network hospitals. PRC is a nationally recognized health care consulting firm with extensive experience conducting Community Health Needs Assessments in hundreds of communities across the United States since 1994.

# Methodology

This assessment incorporates data from multiple sources, including primary research (through the PRC Community Health Survey and PRC Online Key Informant Survey), as well as secondary research (vital statistics and other existing health-related data). It also allows for trending and comparison to benchmark data at the state and national levels.

# PRC Community Health Survey


#### Survey Instrument

The survey instrument used for this study is based largely on the Centers for Disease Control and Prevention (CDC) Behavioral Risk Factor Surveillance System (BRFSS), as well as various other public health surveys and customized questions addressing gaps in indicator data relative to health promotion and disease prevention objectives and other recognized health issues. The final survey instrument was developed by Hackensack Meridian *Health* and PRC and is similar to the previous survey used in the region, allowing for data trending.

#### Community Defined for This Assessment

The study area for the survey effort (referred to as "JFKJRI Service Area" or "JFKJRI" in this report) is defined as each of the residential ZIP Codes comprising the primary service area of Hackensack Meridian JFK Johnson Rehabilitation Institute. This community definition, determined based on the ZIP Codes of residence of most recent patients, is illustrated in the following map.





#### Sample Approach & Design

A precise and carefully executed methodology is critical in asserting the validity of the results gathered in the PRC Community Health Survey. Thus, to ensure the best representation of the population surveyed, a mixed-mode methodology was implemented. This included targeted surveys conducted by PRC via telephone (landline and cell phone) or through online questionnaires, as well as a community outreach component promoted by the study sponsors through social media posting and other communications.

**RANDOM-SAMPLE SURVEYS** (PRC) ► For the targeted administration, PRC administered 735 surveys at random throughout the service area.

**COMMUNITY OUTREACH SURVEYS** (Hackensack Meridian *Health*) > PRC also created a link to an online version of the survey, and Hackensack Meridian *Health* promoted this link throughout the various communities in order to drive additional participation and bolster overall samples. This yielded an additional nine surveys to the overall sample.

In all, 744 surveys were completed through these mechanisms. Once the interviews were completed, these were weighted in proportion to the actual population distribution so as to appropriately represent the JFKJRI Service Area as a whole. All administration of the surveys, data collection, and data analysis was conducted by PRC.

For statistical purposes, for questions asked of all respondents, the maximum rate of error associated with a sample size of 744 respondents is ±3.6% at the 95 percent confidence level.


#### Sample Characteristics

To accurately represent the population studied, PRC strives to minimize bias through application of a proven telephone methodology and random-selection techniques. While this random sampling of the population produces a highly representative sample, it is a common and preferred practice to "weight" the raw data to improve this representativeness even further. This is accomplished by adjusting the results of a random sample to match the geographic distribution and demographic characteristics of the population surveyed (poststratification), so as to eliminate any naturally occurring bias.

The following chart outlines the characteristics of the JFKJRI Service Area sample for key demographic variables, compared to actual population characteristics revealed in census data. [Note that the sample



consisted solely of area residents age 18 and older; data on children were given by proxy by the person most responsible for that child's health care needs, and these children are not represented demographically in this chart.]

Notes: FPL is federal poverty level, based on guidelines established by the US Department of Health & Human Services.

The sample design and the quality control procedures used in the data collection ensure that the sample is representative. Thus, the findings may be generalized to the total population of community members in the defined area with a high degree of confidence.

## **INCOME & RACE/ETHNICITY**

**INCOME** Poverty descriptions and segmentation used in this report are based on administrative poverty thresholds determined by the US Department of Health & Human Services. These guidelines define poverty status by household income level and number of persons in the household (e.g., the 2021 guidelines place the poverty threshold for a family of four at \$26,500 annual household income or lower). In sample segmentation: "low income" refers to community members living in a household with defined poverty status or living just above the poverty level, earning up to twice (<200% of) the poverty threshold; "mid/high income" refers to those households living on incomes which are twice or more (≥200% of) the federal poverty level.

**RACE & ETHNICITY** In analyzing survey results, mutually exclusive race and ethnicity categories are used. All Hispanic respondents are grouped, regardless of identity with any other race group. Other race categories are non-Hispanic categorizations (e.g., "White" reflects non-Hispanic White respondents).

# Online Key Informant Survey

To solicit input from key informants, those individuals who have a broad interest in the health of the community, an Online Key Informant Survey also was implemented as part of this process. A list of recommended participants was provided by Hackensack Meridian Health for the JFKJRI Service Area; this list included names and contact information for physicians, public health representatives, other health professionals, social service providers, and a variety of other community leaders. Potential participants were chosen because of their ability to identify primary concerns of the populations with whom they work, as well as of the community overall.



Key informants were contacted by email, introducing the purpose of the survey and providing a link to take the survey online; reminder emails were sent as needed to increase participation. Local stakeholders were asked to provide input about communities in Middlesex County; the input also included stakeholders who work more regionally or statewide. In all, 37 community stakeholders in the JFKJRI Service Area took part in the Online Key Informant Survey, as outlined below:

Through this process, input was gathered from several individuals whose organizations work with lowincome, minority, or other medically underserved populations. In the online survey, key informants were asked to rate the degree to which various health issues are a problem in their own community. Follow-up questions asked them to describe why they identify problem areas as such and how these might better be addressed. Results of their ratings, as well as their verbatim comments, are included throughout this report as they relate to the various other data presented.

NOTE These findings represent qualitative rather than quantitative data. The Online Key Informant Survey was designed to gather input regarding participants' opinions and perceptions of the health needs of the residents in the area.

# Public Health, Vital Statistics & Other Data

# **Benchmark Data**

#### Trending

A similar survey was administered in the service area in 2019 by PRC on behalf of Hackensack Meridian *Health*. Trending data, as revealed by comparison to prior survey results, are provided throughout this report whenever available (however, note that the geographic service area definition has changed slightly since the 2019 survey data were collected). Historical data for secondary data indicators in the service area Middlesex are also included for the purposes of trending.

## **Regional Data**

Because this assessment was part of a broader, regional project conducted by Hackensack Meridian *Health* (HMH), a regional benchmark for survey indicators is available that represents all of the ZIP Codes in the primary service areas of HMH hospitals throughout central and northern New Jersey. Secondary data for the HMH Service Area are drawn from Essex, Burlington, Camden, Hudson, Hunterdon, Mercer, Middlesex, Monmouth, Morris, Ocean, Somerset, Sussex, Union, and Warren counties.

#### New Jersey Risk Factor Data

Statewide risk factor data are provided where available as an additional benchmark against which to compare local survey findings; these data represent the most recent *BRFSS (Behavioral Risk Factor Surveillance System) Prevalence and Trends Data* published online by the Centers for Disease Control and Prevention. State-level vital statistics are also provided for comparison of secondary data indicators.

## Nationwide Risk Factor Data

Nationwide risk factor data, which are also provided in comparison charts, are taken from the 2020 PRC National Health Survey; the methodological approach for the national study is similar to that employed in this assessment, and these data may be generalized to the US population with a high degree of confidence. National-level vital statistics are also provided for comparison of secondary data indicators.

## Healthy People 2030

Healthy People provides 10-year, measurable public health objectives — and tools to help track progress toward achieving them. Healthy People identifies public health priorities to help individuals, organizations, and communities across the United States improve health and wellbeing. Healthy People 2030, the initiative's fifth iteration, builds on knowledge gained over the first four decades.



Healthy People 2030's overarching goals are to:

- Attain healthy, thriving lives and well-being free of preventable disease, disability, injury, and premature death.
- Eliminate health disparities, achieve health equity, and attain health literacy to improve the health and well-being of all.
- Create social, physical, and economic environments that promote attaining the full potential for health and well-being for all.
- Promote healthy development, healthy behaviors, and well-being across all life stages.
- Engage leadership, key constituents, and the public across multiple sectors to take action and design policies that improve the health and well-being of all.

The Healthy People 2030 framework was based on recommendations made by the Secretary's Advisory Committee on National Health Promotion and Disease Prevention Objectives for 2030. After getting feedback from individuals and organizations and input from subject matter experts, the U.S. Department of Health and Human Services (HHS) approved the framework which helped guide the selection of Healthy People 2030 objectives.



# Information Gaps

While this assessment is quite comprehensive, it cannot measure all possible aspects of health in the community, nor can it adequately represent all possible populations of interest. It must be recognized that these information gaps might in some ways limit the ability to assess all of the community's health needs.

For example, certain population groups — such as the homeless, institutionalized persons, or those who only speak a language other than English or Spanish — are not represented in the survey data. Other population groups — for example, pregnant women, undocumented residents, and members of certain racial/ethnic or immigrant groups — might not be identifiable or might not be represented in numbers sufficient for independent analyses.

In terms of content, this assessment was designed to provide a comprehensive and broad picture of the health of the overall community. However, there are certainly medical conditions that are not specifically addressed.

# **Public Comment**

Hackensack Meridian JFK Johnson Rehabilitation Institute made its prior Community Health Needs Assessment (CHNA) report publicly available on its website; through that mechanism, the hospital requested from the public written comments and feedback regarding the CHNA and implementation strategy. At the time of this writing, Hackensack Meridian JFK Johnson Rehabilitation Institute had not received any written comments. However, through population surveys and key informant feedback for this assessment, input from the broader community was considered and taken into account when identifying and prioritizing the significant health needs of the community. Hackensack Meridian JFK Johnson Rehabilitation Institute will continue to use its website as a tool to solicit public comments and ensure that these comments are considered in the development of future CHNAs.

# SUMMARY OF FINDINGS

# Significant Health Needs of the Community

The following "Areas of Opportunity" represent the significant health needs of the community, based on the information gathered through this Community Health Needs Assessment. From these data, opportunities for health improvement exist in the area with regard to the following health issues (see also the summary tables presented in the following section).

The Areas of Opportunity were determined after consideration of various criteria, including: standing in comparison with benchmark data (particularly national data); identified trends; the preponderance of significant findings within topic areas; the magnitude of the issue in terms of the number of persons affected; and the potential health impact of a given issue. These also take into account those issues of greatest concern to the community stakeholders (key informants) giving input to this process.

## Community Feedback on Prioritization of Health Needs

**Key Informant Input.** Prioritization of the health needs identified in this assessment ("Areas of Opportunity" above) was initially determined based on a prioritization exercise conducted among community stakeholders (representing a cross-section of community-based agencies and organizations) in conjunction with the administration of the Online Key Informant Survey.

In this process, these key informants were asked to rate the severity of a variety of health issues in the community. Insofar as these health issues were identified through the data above and/or were identified as top concerns among key informants, their ranking of these issues informed the following priorities:

- 1. Mental Health
- 2. Substance Abuse
- 3. Nutrition, Physical Activity & Weight
- 4. Diabetes
- 5. Heart Disease & Stroke
- 6. Cancer
- 7. Access to Healthcare Services
- 8. Injury & Violence
- 9. Potentially Disabling Conditions
- 10. Respiratory Disease
- 11. Oral Health

Not prioritized within the list above is **Social Determinants of Health**, which potentially impacts outcomes for all of the above.

**Community Forums.** Throughout the week of August 15, 2022, Hackensack Meridian *Health* convened a series of meetings with its network hospitals and community partners to review and discuss the findings of this assessment. At that time, it was determined to address the issues identified above within the network's reframed priority areas as follows, each viewed through the lens of health equity and social determinants:

- Mental Wellbeing (e.g., behavioral health, mental health, substance use, stress, ACEs)
- Healthy Living (e.g., chronic disease, prevention, and awareness)
- Access to Care (e.g., health insurance, transportation, availability/capacity of providers)

#### Hospital Implementation Strategy

Hackensack Meridian JFK Johnson Rehabilitation Institute will use the information from this Community Health Needs Assessment to develop an Implementation Strategy to address the significant health needs in the community. While the hospital will likely not implement strategies for all of the health issues listed above, the results of this prioritization exercise will be used to inform the development of the hospital's action plan to guide community health improvement efforts in the coming years.

## Total Population by Age Groups (2016-2020)



# Social Determinants of Health

## ABOUT SOCIAL DETERMINANTS OF HEALTH

Social determinants of health (SDOH) are the conditions in the environments where people are born, live, learn, work, play, worship, and age that affect a wide range of health, functioning, and quality-oflife outcomes and risks.

Social determinants of health (SDOH) have a major impact on people's health, well-being, and quality of life. Examples of SDOH include:

- Safe housing, transportation, and neighborhoods
- Racism, discrimination, and violence
- Education, job opportunities, and income
- Access to nutritious foods and physical activity opportunities
- Polluted air and water
- Language and literacy skills

SDOH also contribute to wide health disparities and inequities. For example, people who don't have access to grocery stores with healthy foods are less likely to have good nutrition. That raises their risk of health conditions like heart disease, diabetes, and obesity - and even lowers life expectancy relative to people who do have access to healthy foods.


Just promoting healthy choices won't eliminate these and other health disparities. Instead, public health organizations and their partners in sectors like education, transportation, and housing need to take action to improve the conditions in people's environments.







Household Member has Lost a Job, Hours/Wages, or Health Insurance as a Result of the Pandemic (JFKJRI Service Area, 2022)



Population With No High School Diploma (Population Age 25+ Without a High School Diploma or Equivalent, 2016-2020)






### Unhealthy or Unsafe Housing Conditions in the Past Year (JFKJRI Service Area, 2022)







### ABOUT MENTAL HEALTH & MENTAL DISORDERS

About half of all people in the United States will be diagnosed with a mental disorder at some point in their lifetime. ...Mental disorders affect people of all age and racial/ethnic groups, but some populations are disproportionately affected. And estimates suggest that only half of all people with mental disorders get the treatment they need.

In addition, mental health and physical health are closely connected. Mental disorders like depression and anxiety can affect people's ability to take part in healthy behaviors. Similarly, physical health problems can make it harder for people to get treatment for mental disorders. Increasing screening for mental disorders can help people get the treatment they need.



"Now thinking about your mental health, which includes stress, depression and problems with emotions, would you say that, in general, your mental health is: excellent, very good, good, fair, or poor?"





### Impact of the Pandemic on Mental Health


"Since the start of the pandemic, would you say or mental health has: improved, stayed about the same, or become worse?"

Have Been Diagnosed With a Depressive Disorder






Access to Mental Health Providers





Increase in anxiety, depression specially among youth. Lack of available appointments, lack of bilingual services. Funding came through COVID to expand mental health services, but services are coming to an end. – Public Health Representative (Middlesex County)

High incidence. - Physician (Middlesex County)

Due to COVID-19

COVID and the economic crisis has resulted in mental health issues in the community. – Health Provider (Northern and Central New Jersey)

Social isolation for older adults, especially during COVID 19. – Social Service Provider (Middlesex County)

### Awareness/Education

Understanding that they may have a problem that should be talked about with their health care provider. I feel too many people are either in denial or ignore the possibility that there is a problem. The pandemic and the effects of the pandemic have made some of these mental issues more of a problem than prior. – Community/Business Leader (Middlesex County)

### **Disease Management**

Staying healthy, staying on medications, personal hygiene, having a place to go during the day. – Community/ Business Leader (Northern and Central New Jersey)



## Age-Adjusted Death Rates for Selected Causes

### AGE-ADJUSTED DEATH RATES

In order to compare mortality in the region with other localities (in this case, New Jersey and the United States), it is necessary to look at rates of death — these are figures which represent the number of deaths in relation to the population size (such as deaths per 100,000 population, as is used here).

Furthermore, in order to compare localities without undue bias toward younger or older populations, the common convention is to adjust the data to some common baseline age distribution. Use of these "age-adjusted" rates provides the most valuable means of gauging mortality against benchmark data, as well as Healthy People 2030 objectives.

## ABOUT HEART DISEASE & STROKE

Heart disease is the leading cause of death in the United States, and stroke is the fifth leading cause. ...Heart disease and stroke can result in poor quality of life, disability, and death. Though both diseases are common, they can often be prevented by controlling risk factors like high blood pressure and high cholesterol through treatment.

In addition, making sure people who experience a cardiovascular emergency — like stroke, heart attack, or cardiac arrest — get timely recommended treatment can reduce their risk for long-term disability and death. Teaching people to recognize symptoms is key to helping more people get the treatment they need.







## Total Cardiovascular Risk

Total cardiovascular risk reflects the individual-level risk factors which put a person at increased risk for cardiovascular disease, including:

- High Blood Pressure
- High Blood Cholesterol
- Cigarette Smoking
- Physical Inactivity
- Overweight/Obesity

Modifying these behaviors and adhering to treatment for high blood pressure and cholesterol are critical both for preventing and for controlling cardiovascular disease.



Among those rating this issue as a "major problem," reasons related to the following:

### Prevalence/Incidence

Rates of death are high from heart disease and stroke. – Community/Business Leader (Northern and Central New Jersey)

Every 40 seconds someone has a stroke. Heart disease is the leading cause of death in the US. – Public Health Representative (Middlesex County)

Hear too much about it occurring and we aren't the healthiest folks in the US. – Community/Business Leader (Middlesex County)

It's a leading cause of death, attributed to a variety of other factors. I believe many do not realize or ignore signs and symptoms, thus they don't know it's a problem until it's too late. – Community/Business Leader (Middlesex County)

High incidence. – Physician (Middlesex County)

Heart disease is the main cause of death in the US. Not sure if that is the case in Middlesex County but it is likely. – Health Provider (Middlesex County)

Many residents suffer from some type of heart disease. - Community/Business Leader (Middlesex County)

#### Prevention/Screenings

Health screenings reveal major issue in the community regardless of income or health insurance coverage. – Health Provider (Middlesex County)

#### Awareness/Education

Lack of knowledge of symptoms, need for more community health education. No access to wellness and physical activities for low-income residents. Need for culturally appropriate health education programs. – Public Health Representative (Middlesex County)



## Cancer

### ABOUT CANCER

Cancer is the second leading cause of death in the United States. ...The cancer death rate has declined in recent decades, but over 600,000 people still die from cancer each year in the United States. Death rates are higher for some cancers and in some racial/ethnic minority groups. These disparities are often linked to social determinants of health, including education, economic status, and access to health care.

Interventions to promote evidence-based cancer screenings — such as screenings for lung, breast, cervical, and colorectal cancer — can help reduce cancer deaths. Other effective prevention strategies include programs that increase HPV vaccine use, prevent tobacco use and promote quitting, and promote healthy eating and physical activity. In addition, effective targeted therapies and personalized treatment are key to helping people with cancer live longer.





## **ABOUT CANCER RISK**

Reducing the nation's cancer burden requires reducing the prevalence of behavioral and environmental factors that increase cancer risk.

- All cancers caused by cigarette smoking could be prevented. At least one-third of cancer deaths that occur in the United States are due to cigarette smoking.
- According to the American Cancer Society, about one-third of cancer deaths that occur in the United States each year are due to nutrition and physical activity factors, including obesity.

## **Cancer Screenings**

The American Cancer Society recommends that both men and women get a cancer-related checkup during a regular doctor's checkup. It should include examination for cancers of the thyroid, testicles, ovaries, lymph nodes, oral cavity, and skin, as well as health counseling about tobacco, sun exposure, diet and nutrition, risk factors, sexual practices, and environmental and occupational exposures.

### FEMALE BREAST CANCER

The US Preventive Services Task Force (USPSTF) recommends biennial screening mammography for women aged 50 to 74 years.

### **CERVICAL CANCER**

The US Preventive Services Task Force (USPSTF) recommends screening for cervical cancer every 3 years with cervical cytology alone in women aged 21 to 29 years. For women aged 30 to 65 years, the USPSTF recommends screening every 3 years with cervical cytology alone, every 5 years with high-risk human papillomavirus (hrHPV) testing alone, or every 5 years with hrHPV testing in combination with cytology (cotesting). The USPSTF recommends against screening for cervical cancer in women who have had a hysterectomy with removal of the cervix and do not have a history of a high-grade precancerous lesion (i.e., cervical intraepithelial neoplasia [CIN] grade 2 or 3) or cervical cancer.

### PROSTATE CANCER

The US Preventive Services Task Force (USPSTF) recommends that the decision to be screened for prostate cancer should be an individual one for men age 55 to 69 years. The USPSTF recommends against PSA-based screening in men age 70 and older.

### COLORECTAL CANCER

The US Preventive Services Task Force (USPSTF) recommends screening for colorectal cancer starting at age 50 years and continuing until age 75 years.

Note that other organizations (e.g., American Cancer Society, American Academy of Family Physicians, American College of Physicians, National Cancer Institute) may have slightly different screening guidelines.

Screening levels in the community were measured in the PRC Community Health Survey relative to four cancer sites: female breast cancer (mammography); cervical cancer (Pap smear testing); colorectal cancer (sigmoidoscopy and fecal occult blood testing); and prostate cancer (PSA).

## BREAST CANCER SCREENING ► "A mammogram is an x-ray of each breast to look for cancer. How long has it been since you had your last mammogram?"

Breast cancer screening is calculated here among women age 50 to 74 who indicate mammography within the past 2 years.

CERVICAL CANCER SCREENING ▶ "A Pap test is a test for cancer of the cervix. How long has it been since you had your last Pap test?"

[If Pap test in the past five years] "HPV, or the human papillomavirus, is a common infection that can cause several types of cancer. When you received your last Pap test, were you screened for HPV?"



#### "Have you ever had a hysterectomy?"

"Appropriate cervical cancer screening" includes Pap smear testing (cervical cytology) every three years in women age 21 to 29 and Pap smear testing and/or HPV testing every 5 years in women age 30 to 65. Women 21 to 65 with hysterectomy are excluded.


COLORECTAL CANCER SCREENING ► "Sigmoidoscopy and colonoscopy are exams in which a tube is inserted in the rectum to view the colon for signs of cancer or other health problems. How long has it been since your last sigmoidoscopy or colonoscopy?"

"A blood stool test is a test that may use a special kit at home to determine whether the stool contains blood. How long has it been since you had your last blood stool test?"

"Appropriate colorectal cancer screening" is calculated here among men and women age 50 to 75 years who have had a fecal occult blood test within the past year and/or a lower endoscopy (sigmoidoscopy or colonoscopy) within the past 10 years.

PROSTATE CANCER SCREENING ► "A prostate-specific antigen test, also called a PSA test, is a blood test used to check men for prostate cancer. How long has it been since you had your last PSA test?"

"Prostate cancer screening" is calculated here among men age 40 and older who indicate screening within the past 2 years.





Among those rating this issue as a "major problem," reasons related to the following:

### Prevalence/Incidence

High incidence. - Physician (Middlesex County)

Cancer has no boundaries and affects many people and families. Most people have been touched by cancer in some way. Prevalence increases as we age and is associated with lifestyle factors. – Public Health Representative (Middlesex County)

High rate of it and varied types. Too many diagnoses, very late due to lack of education on them, especially to minority communities. – Health Provider (Northern and Central New Jersey)

High cases seem to be reported. - Community/Business Leader (Middlesex County)

Until there is a cure there will always be a need for care and centers. – Community/Business Leader (Middlesex County)

The number of people that we hear are suffering from cancer seems to be increasing. – Community/Business Leader (Middlesex County)

### Diagnosis/Treatment

In vulnerable communities, residents are waiting too long to come in for screenings and services due to lack of knowledge and health insurance and mistrust of the system. – Public Health Representative (Middlesex County)



Too many people in our community still smoke, too many people either don't get the cancer screenings that they are due or overdue for, or even know they should be getting cancer screenings regularly. There is inherit bias and racism involved so there are entire communities that aren't even being approached or educated about the need for cancer screening. We are lucky to have many cancer treatment centers in Northern and Central NJ, but navigating health systems can be very difficult, especially if English is not your first language. People are afraid of hearing they have cancer...so if they don't go to the doctors, they won't hear it. Also, our area is certainly affected because people are overweight, consume alcohol, and don't exercise enough. – Community/Business Leader (Northern and Central New Jersey)

### Skin Cancer

Skin cancer, many people do not protect their skin against damaging rays. They are not being cautious when in the elements. – Community/Business Leader (Middlesex County)

## Respiratory Disease (Including COVID-19)

### ABOUT RESPIRATORY DISEASE

Respiratory diseases affect millions of people in the United States. ...More than 25 million people in the United States have asthma. Strategies to reduce environmental triggers and make sure people get the right medications can help prevent hospital visits for asthma. In addition, more than 16 million people in the United States have COPD (chronic obstructive pulmonary disease), which is a major cause of death. Strategies to prevent the disease — like reducing air pollution and helping people quit smoking — are key to reducing deaths from COPD.

Interventions tailored to at-risk groups can also help prevent and treat other respiratory diseases — for example, pneumonia in older adults and pneumoconiosis in coal miners. And increasing lung cancer screening rates can help reduce deaths from lung cancer through early detection and treatment.








COVID-19: Age-Adjusted Mortality (2020 Age-Adjusted Deaths per 100,000 Population)



Pandemic continues to have an enormous impact. - Physician (Middlesex County)

By the number of affected people in the community. Community outreach and health services have been very impactful in reaching people about the virus, vaccinations, and boosters. – Social Service Provider (Middlesex County)

The rate of death diagnoses as per NJ government information. – Health Provider (Northern and Central New Jersey)

Middlesex County has a high incidence and mortality rate for COVID-19. – Community/Business Leader (Middlesex County)

COVID impacted our city heavily during 2020 and 2021. The limited number of vaccinations acquired, and the significant infection rate took its toll on the system. – Community/Business Leader (Middlesex County)

#### Awareness/Education

Social media spreading misinformation. The vaccine became a political issue, and it is not seen as a public health issue. People have questions, and no access to trusted messengers to ask questions. Low-income residents lost income, are behind with rent & utilities and the increase in the cost of food and gas is going to make it very difficult for families to come out of this crisis. – Public Health Representative (Middlesex County)

Confusing information from news sources and that many people obtain information from unreliable resources and spread misinformation. – Social Service Provider (Middlesex County)

Inaccurate information, language barriers (many people speak/read dialects of the Spanish Language), fear, requirements to work or no pay so people go to work even though they are sick, have been exposed, or other colleagues are sick. Large new American population in UC without access to resources. – Health Provider (Northern and Central New Jersey)

### Vaccination Rates

Still a large number of people who do not trust the vaccination process or do not follow CDC protocols. – Health Provider (Middlesex County)

### Impact on Quality of Life

Total disruption of lives. - Health Provider (Middlesex County)

#### **Co-Occurrences**

Dementia, not enough medical advances, services, support, treatment. Autism, not enough services and support. – Community/Business Leader (Middlesex County)

## Injury & Violence

### **ABOUT INJURY & VIOLENCE**

**INJURY** ► In the United States, unintentional injuries are the leading cause of death in children, adolescents, and adults younger than 45 years. ...Many unintentional injuries are caused by motor vehicle crashes and falls, and many intentional injuries involve gun violence and physical assaults. Interventions to prevent different types of injuries are key to keeping people safe in their homes, workplaces, and communities.

Drug overdoses are now the leading cause of injury deaths in the United States, and most overdoses involve opioids. Interventions to change health care providers' prescribing behaviors, distribute naloxone to reverse overdoses, and provide medications for addiction treatment for people with opioid use disorder can help reduce overdose deaths involving opioids.

VIOLENCE ► Almost 20,000 people die from homicide every year in the United States, and many more people are injured by violence. ...Many people in the United States experience physical assaults, sexual violence, and gun-related injuries. Adolescents are especially at risk for experiencing violence. Interventions to reduce violence are needed to keep people safe in their homes, schools, workplaces, and communities.

Children who experience violence are at risk for long-term physical, behavioral, and mental health problems. Strategies to protect children from violence can help improve their health and well-being later in life.






### Violent Crime






> Have Ever Been Hit, Slapped, Pushed, Kicked, or Hurt in Any Way by an Intimate Partner



But interventions to help people manage diabetes can help reduce the risk of complications. 







## **Kidney Disease**

#### ABOUT KIDNEY DISEASE

More than 1 in 7 adults in the United States may have chronic kidney disease (CKD), with higher rates in low-income and racial/ethnic minority groups. And most people with CKD don't know they have it. ...People with CKD are more likely to have heart disease and stroke — and to die early. Managing risk factors like diabetes and high blood pressure can help prevent or delay CKD. Strategies to make sure more people with CKD are diagnosed early can help people get the treatment they need.

Recommended tests can help identify people with CKD to make sure they get treatments and education that may help prevent or delay kidney failure and end-stage kidney disease (ESKD). In addition, strategies to make sure more people with ESKD get kidney transplants can increase survival rates and improve quality of life.

Kidney Disease: Age-Adjusted Mortality Trends (Annual Average Deaths per 100,000 Population)
















## Limited in Activities in Some Way Due to a Physical, Mental, or Emotional Problem





## Alzheimer's Disease

#### **ABOUT DEMENTIA**

Alzheimer's disease is the most common cause of dementia and the sixth leading cause of death in U.S. adults.1 Nearly 6 million people in the United States have Alzheimer's, and that number will increase as the population ages.

Dementia refers to a group of symptoms that cause problems with memory, thinking, and behavior. People with dementia are more likely to be hospitalized, and dementia is linked to high health care costs.

While there's no cure for Alzheimer's disease, early diagnosis and supportive care can improve quality of life. And efforts to make sure adults with symptoms of cognitive decline — including memory loss — are diagnosed early can help improve health outcomes in people with dementia. Interventions to address caregiving needs can also help improve health and well-being in people with dementia.




Alzheimer's Disease: Age-Adjusted Mortality Trends





#### ABOUT INFANT HEALTH

Keeping infants healthy starts with making sure women get high-quality care during pregnancy and improving women's health in general. After birth, strategies that focus on increasing breastfeeding rates and promoting vaccinations and developmental screenings are key to improving infants' health. Interventions that encourage safe sleep practices and correct use of car seats can also help keep infants safe.

The infant mortality rate in the United States is higher than in other high-income countries, and there are major disparities by race/ethnicity. Addressing social determinants of health is critical for reducing these disparities.




## **Birth Outcomes & Risks**

### ABOUT FAMILY PLANNING


Nearly half of pregnancies in the United States are unintended, and unintended pregnancy is linked to many negative outcomes for both women and infants. ...Unintended pregnancy is linked to outcomes like preterm birth and postpartum depression. Interventions to increase use of birth control are critical for preventing unintended pregnancies. Birth control and family planning services can also help increase the length of time between pregnancies, which can improve health for women and their infants.

Adolescents are at especially high risk for unintended pregnancy. Although teen pregnancy and birth rates have gone down in recent years, close to 200,000 babies are born to teen mothers every year in the United States. Linking adolescents to youth-friendly health care services can help prevent pregnancy and sexually transmitted infections in this age group.

### Teen Birth Rate (Births to Adolescents Age 15-19 per 1,000 Females Age 15-19, 2014-2020)



Public health interventions that focus on helping everyone get healthy foods are key to reducing food insecurity and hunger and improving health.


## Daily Recommendation of Fruits/Vegetables





Although most people don't get the recommended amount of physical activity, it can be especially hard for older adults and people with chronic diseases or disabilities.



Strategies to promote physical activity at home, at school, and at childcare centers can also increase activity in children and adolescents.

## Meeting Physical Activity Recommendations

#### ADULTS: RECOMMENDED LEVELS OF PHYSICAL ACTIVITY

Adults should do 2 hours and 30 minutes a week of moderate-intensity (such as walking), or 1 hour and 15 minutes (75 minutes) a week of vigorous-intensity **aerobic** physical activity (such as jogging), or an equivalent combination of moderate- and vigorous-intensity aerobic physical activity. The guidelines also recommend that adults do **muscle-strengthening** activities, such as push-ups, situps, or activities using resistance bands or weights. These activities should involve all major muscle groups and be done on two or more days per week.

The report finds that nationwide nearly 50 percent of adults are getting the recommended amounts of aerobic activity and about 30 percent are engaging in the recommended muscle-strengthening activity.

To measure physical activity frequency, duration, and intensity, respondents were asked:

"During the past month, what type of physical activity or exercise did you spend the most time doing?"

"And during the past month, how many times per week or per month did you take part in this activity?"

"And when you took part in this activity, for how many minutes or hours did you usually keep at it?"

Respondents could answer the above series for up to two types of physical activity. The specific activities identified (e.g., jogging, basketball, treadmill, etc.) determined the intensity values assigned to that respondent when calculating total aerobic physical activity hours/minutes.

Respondents were also asked about strengthening exercises:

"During the past month, how many times per week or per month did you do physical activities or exercises to strengthen your muscles? Do not count aerobic activities like walking, running, or bicycling. Please include activities using your own body weight, such as yoga, situps, or push-ups, and those using weight machines, free weights, or elastic bands."


"Meeting physical activity recommendations" includes adequate levels of <u>both</u> aerobic and strengthening activity:

- Aerobic activity is at least 150 minutes per week of light to moderate activity, 75 minutes per week of vigorous physical activity, or an equivalent combination of both;
- Strengthening activity is at least 2 sessions per week of exercise designed to strengthen muscles.



# Weight Status

## ABOUT OVERWEIGHT & OBESITY

Obesity is linked to many serious health problems, including type 2 diabetes, heart disease, stroke, and some types of cancer. Some racial/ethnic groups are more likely to have obesity, which increases their risk of chronic diseases.

Culturally appropriate programs and policies that help people eat nutritious foods within their calorie needs can reduce overweight and obesity. Public health interventions that make it easier for people to be more physically active can also help them maintain a healthy weight.

Body Mass Index (BMI), which describes relative weight for height, is significantly correlated with total body fat content. The BMI should be used to assess overweight and obesity and to monitor changes in body weight. In addition, measurements of body weight alone can be used to determine efficacy of weight loss therapy. BMI is calculated as weight (kg)/height squared (m<sup>2</sup>). To estimate BMI using pounds and inches, use: [weight (pounds)/height squared (inches<sup>2</sup>)] x 703.

In this report, overweight is defined as a BMI of 25.0 to 29.9 kg/m<sup>2</sup> and obesity as a BMI  $\geq$ 30 kg/m<sup>2</sup>. The rationale behind these definitions is based on epidemiological data that show increases in mortality with BMIs above 25 kg/m<sup>2</sup>. The increase in mortality, however, tends to be modest until a BMI of 30 kg/m<sup>2</sup> is reached. For persons with a BMI  $\geq$ 30 kg/m<sup>2</sup>, mortality rates from all causes, and especially from cardiovascular disease, are generally increased by 50 to 100 percent above that of persons with BMIs in the range of 20 to 25 kg/m<sup>2</sup>.




## Prevalence of Total Overweight (Overweight and Obese)







## Children's Weight Status

#### ABOUT WEIGHT STATUS IN CHILDREN & TEENS

In children and teens, body mass index (BMI) is used to assess weight status - underweight, healthy weight, overweight, or obese. After BMI is calculated for children and teens, the BMI number is plotted on the CDC BMI-for-age growth charts (for either girls or boys) to obtain a percentile ranking. Percentiles are the most commonly used indicator to assess the size and growth patterns of individual children in the United States. The percentile indicates the relative position of the child's BMI number among children of the same sex and age.

- Underweight
- <5<sup>th</sup> percentile Healthy Weight ≥5<sup>th</sup> and <85<sup>th</sup> percentile





## Substance Abuse

#### ABOUT DRUG & ALCOHOL USE

More than 20 million adults and adolescents in the United States have had a substance use disorder in the past year. ...Substance use disorders can involve illicit drugs, prescription drugs, or alcohol. Opioid use disorders have become especially problematic in recent years. Substance use disorders are linked to many health problems, and overdoses can lead to emergency department visits and deaths.

Effective treatments for substance use disorders are available, but very few people get the treatment they need. Strategies to prevent substance use — especially in adolescents — and help people get treatment can reduce drug and alcohol misuse, related health problems, and deaths.














#### Used a Prescription Opioid in the Past Year (JFKJRI Service Area, 2022)





Connecting to addicts when they are most receptive to care. - Health Provider (Middlesex County)



## **Tobacco Use**

#### ABOUT TOBACCO USE

More than 16 million adults in the United States have a disease caused by smoking cigarettes, and smoking-related illnesses lead to half a million deaths each year.


Most deaths and diseases from tobacco use in the United States are caused by cigarettes. Smoking harms nearly every organ in the body and increases the risk of heart disease, stroke, lung diseases, and many types of cancer. Although smoking is widespread, it's more common in certain groups, including men, American Indians/Alaska Natives, people with behavioral health conditions, LGBT people, and people with lower incomes and education levels.

Several evidence-based strategies can help prevent and reduce tobacco use and exposure to secondhand smoke. These include smoke-free policies, price increases, and health education campaigns that target large audiences. Methods like counseling and medication can also help people stop using tobacco.





### Member of Household Smokes at Home







HIV

#### ABOUT HIV & SEXUALLY TRANSMITTED INFECTIONS

Although many sexually transmitted infections (STIs) are preventable, there are more than 20 million estimated new cases in the United States each year — and rates are increasing. In addition, more than 1.2 million people in the United States are living with HIV (human immunodeficiency virus).

Adolescents, young adults, and men who have sex with men are at higher risk of getting STIs. And people who have an STI may be at higher risk of getting HIV. Promoting behaviors like condom use can help prevent STIs.


Strategies to increase screening and testing for STIs can assess people's risk of getting an STI and help people with STIs get treatment, improving their health and making it less likely that STIs will spread to others. Getting treated for an STI other than HIV can help prevent complications from the STI but doesn't prevent HIV from spreading.



# ACCESS TO HEALTH CARE

#### ABOUT HEALTH CARE ACCESS

Many people in the United States don't get the health care services they need. ...About 1 in 10 people in the United States don't have health insurance. People without insurance are less likely to have a primary care provider, and they may not be able to afford the health care services and medications they need. Strategies to increase insurance coverage rates are critical for making sure more people get important health care services, like preventive care and treatment for chronic illnesses.

Sometimes people don't get recommended health care services, like cancer screenings, because they don't have a primary care provider. Other times, it's because they live too far away from health care providers who offer them. Interventions to increase access to health care professionals and improve communication — in person or remotely — can help more people get the care they need.

## Lack of Health Insurance Coverage

Survey respondents in the JFKJRI service area were asked a series of questions to determine their health care insurance coverage, if any, from either private or government-sponsored sources.

"Do you have any government-assisted health care coverage, such as Medicare, Medicaid (or another state-sponsored program), or VA/military benefits?"

"Do you currently have: health insurance you get through your own or someone else's employer or union; health insurance you purchase yourself or get through a health insurance exchange website; or, you do not have health insurance and pay for health care entirely on your own?"





"Was there a time in the past 12 months when a lack of transportation made it difficult or prevented you from seeing a doctor or making a medical appointment?"

"Was there a time in the past 12 months when you were not able to see a doctor because the office hours were not convenient?"







## Went Without Needed or Planned Medical Care Due to the Pandemic (JFKJRI Service Area, 2022)



## Access to Care/Services

Limited number of primary care physicians and specialists, particularly those that do not accept certain insurances. Also, many residents do not have insurance or are under insured. Additionally, diets are not the healthiest. – Community/Business Leader (Middlesex County)

Lack of holistic health resources like massage therapy, lymphatic drainage therapy, yoga. – Health Provider (Middlesex County)

Limited information available, difficult applications, literacy challenges, fear of using any type of government funded programs. – Health Provider (Northern and Central New Jersey)

The population we serve has a distrust of health care, lack of access to good health care and a lack of funds especially for medications. This is compounded by the inability to take time off from work to address health care needs. – Community/Business Leader (Middlesex County)

#### Transportation

Transportation issues and navigating health care systems. - Public Health Representative (Middlesex County)

Transportation is definitely a barrier, as well as services that are affordable and provided in people's native language. – Health Provider (Middlesex County)

Transportation, lack of availability of appointments, waiting time with children, lack of health insurance, language barriers and low health literacy levels. – Public Health Representative (Middlesex County)

#### Affordable Care/Services

Affordable care with accessible providers who provide no fee or low fee care. – Health Provider (Middlesex County)

#### Insurance Issues

Lack of insurance, under insured. - Community/Business Leader (Middlesex County)

#### Income/Poverty

Wealth and health issue. - Community/Business Leader (Middlesex County)

Access for Medicare/Medicaid Patients

Very difficult for patients on Medicaid and without insurance to get health care. - Physician (Middlesex County)



# **Primary Care Services**

## ABOUT PREVENTIVE CARE

Getting preventive care reduces the risk for diseases, disabilities, and death --- yet millions of people in the United States don't get recommended preventive health care services.

Children need regular well-child and dental visits to track their development and find health problems early, when they're usually easier to treat. Services like screenings, dental check-ups, and vaccinations are key to keeping people of all ages healthy. But for a variety of reasons, many people don't get the preventive care they need. Barriers include cost, not having a primary care provider, living too far from providers, and lack of awareness about recommended preventive services.

Teaching people about the importance of preventive care is key to making sure more people get recommended services. Law and policy changes can also help more people access these critical services.




## Have Visited a Physician for a Checkup in the Past Year

# **Oral Health**

## ABOUT ORAL HEALTH

Tooth decay is the most common chronic disease in children and adults in the United States. ...Regular preventive dental care can catch problems early, when they're usually easier to treat. But many people don't get the care they need, often because they can't afford it. Untreated oral health problems can cause pain and disability and are linked to other diseases.

Strategies to help people access dental services can help prevent problems like tooth decay, gum disease, and tooth loss. Individual-level interventions like topical fluorides and community-level interventions like community water fluoridation can also help improve oral health. In addition, teaching people how to take care of their teeth and gums can help prevent oral health problems.





Healthy People 2030 = 45.0% or Higher



Hard to find a dentist for Medicaid and uninsured patients. - Physician (Middlesex County)



# JOHNSON REHABILITATION INSTITUTE 2020-2022 EVALUATION OF IMPACT REPORT

## Background

In 2019, Hackensack Meridian *Health* JFK Johnson Rehabilitation Institute completed a Community Health Needs Assessment (CHNA) and developed a supporting Community Health Implementation Plan (CHIP) to address identified health priorities. The strategies implemented to address the health priorities reflect Hackensack Meridian *Health's* mission and commitment to improving the health and well-being of the community.

Guided by the findings from the 2019 CHNA and input from key community stakeholders, Hackensack Meridian *Health* leadership identified the following priorities to be addressed by the CHIP:

- Chronic & Complex Conditions
- Wellness & Prevention (Risk Factors)
- Social Determinants of Health & Access to Care

The arrival of COVID-19 shortly after the approval of the CHNA and CHIP shifted the priorities of our community and the world. We swiftly adapted to enact measures to keep staff and patients safe, ensure continuity of care, integrate new technologies and strategies to adjust to the new environment and leverage partnerships to meet emerging needs. The following sections outline our work to impact the priority health needs and respond to COVID-19 in our area.

Additionally, we have supported patients, staff and the broader community financial assistance, food and medicine, education, and social and emotional support throughout the pandemic.
