
A Leader in Sustainability

How We Are Addressing Social Determinants of Health

Hackensack Meridian Health is committed to addressing the top social determinants of health (SDoH)—utilizing data from our network screening tool to drive our interventions. To date, the network has screened 950,000 patients and provided 3 million referrals.

Fresh Match Program

In 2023, Hackensack Meridian Health launched the Fresh Match program that will make fresh produce more accessible to families in need. With support from a \$3 million grant from the State of New Jersey, a \$500,000 grant from the USDA's National Institute of Food and Agriculture and a \$500,000 match from donors to the Hackensack Meridian Health Foundation, we are partnering with grocery retailers to provide families receiving Supplemental Nutrition Assistance Program (SNAP) benefits with a dollar-for-dollar match to buy fresh produce.

Circle of Compassion Program

Through our Circle of Compassion program, Hackensack Meridian Health has provided financial support to team members facing emergent and unforeseen catastrophic events. Since its inception in 2019, the program has provided more than \$3 million to nearly 2,500 team members. The program recently added committee members from our SDoH team, which has helped us reshape the fund to better meet the emergent and underlying needs of our team members.

Human Dimension Curriculum

We are training the next generation of doctors about these critical social needs. The Human Dimension is ingrained in the Hackensack Meridian School of Medicine through service-learning experiences and integrated curriculum, which allows students to learn about the many determinants of health.

Access to Housing While Pursuing Nursing Education

JFK Medical Center Foundation refurbished the Audrey Snyder Single Parent Residence at the JFK-Muhlenberg Harold B. & Dorothy A. Snyder School of Nursing in Plainfield, New Jersey. The Single Parent Program provides full scholarships and rent-free living for single-parent nursing students and their children—critical support to help each student achieve the dream of becoming a registered nurse. The updates were made possible thanks to a \$35,000 grant from the Harold B. and Dorothy A. Snyder Foundation, combined with a gift from the Hyde and Watson Foundation.

Transparency, Accountability and Ethical Decision-making



- Revising our data privacy policy to address reproductive rights, 21st Century Cures Act and the evolving impact of artificial intelligence
- Integrating sustainability into our Enterprise Risk Management Program

Using AI to Improve Health Outcomes

In late 2023, Hackensack Meridian *Health* joined 27 other hospital systems from across the country in a commitment to move toward safe, secure and trustworthy purchasing and use of artificial intelligence (AI) technology. The White House highlighted this voluntary commitment as a key part of the federal government's whole-ofsociety efforts to advance Al for the health and wellbeing of Americans.



ESG Organizational Structure

Looking Ahead

2024 ESG Strategy for Hackensack Meridian Health

In 2024, we will continue our work in implementing a clear multi-year framework for Hackensack Meridian Health to enhance business practices through an ESG lens with the following key priorities:

1. Build and launch ESG dashboard with network-wide accountability

Measuring and reporting on our work is critical to ensure transparency and accountability. Hackensack Meridian Health will begin building our ESG dashboard in early 2024 with a phased launch. The dashboard will be systematically reviewed by executive leadership and the relevant board committees. Our first phase will include scope 1 and 2 emissions to align with our Climate Pledge commitments.

2. Internal areas of focus

Leadership in key areas of ESG will continue to evolve in 2024. Internally, Hackensack Meridian *Health* has prioritized several areas, based on the SWOT analysis, with the goal of enhancing our leadership and aligning for impact and compliance:

- Launch largest solar array and battery storage project for a non-profit health care organization in the U.S. with Bernhard
- ▶ Achievement of network-wide health equity, responsible use of health data and other ESG-aligned certifications
- ▶ Develop Hackensack Meridian *Health* global donation program
- ▶ Align community partnership and sponsorships with ESG priorities

3. Advocacy areas of focus

Public policy can drive health equity, sustain evidencebased programs and build stronger communities. Hackensack Meridian *Health* will continue to use its voice through education and advocacy. In 2024, the network's ESG advocacy will focus on food insecurity, a key pillar of our social determinants of health work. We will engage on both the federal and state levels to expand publicprivate partnership, enhance existing food systems and support our partners in this critical work.




Our Multi-Year Vision
